Conditions:

- Selected Party/Parties should execute an agreement with the Board;
- Selected Party/parties are liable to obtain necessary permits, licenses, insurances and other statutory requirements from concerned authorities necessary for display of advertisements
- Exhibition of advertisement in no way should violate the customs, belief or rituals of the temples or hinder access or create inconveniences to the devotees or officers in any manner
- Contents of the advertisements should not in any way be unbecoming of the culture and traditions of a place of spirituality
- Interested parties can also visit the sites with permission from the Devaswom Officers/JDOs/DMs.
- The rate quoted should be per square feet
- The contract would be for two years. The rate for the second year would be increased by ten percent of that quoted for the first year.
- Tenders not containing EMD, Registration details and PAN would be rejected.
- Without prejudice to the above conditions Cochin Devaswom Board would be at liberty to reject any offer without assigning any reasons thereof or cancel this tender.
- Location of the hordings should be specifically mentioned in the tender.
