Bidders shall remit the cost of tender documents with schedule and EMD using the online payment options of e-procurement system only.

Bidders are advised to visit the 'Downloads' section of e-procurement website ([www.etenders.kerala.gov.in](http://www.etenders.kerala.gov.in)) for detailed instructions on making online payment using internet banking facilities of SBI or by using NEFT/RTGS facility. Bidders opting for NEFT/RTGS facility of online

payment are advised to exercise this option at least 48 hours before the closing of the bid to ensure that payment towards cost of tender documents with schedule and EMD are credited and a confirmation is reflected in the e-procurement system. The online NEFT/RTGS remittance form provided by e-procurement system for making a NEFT/RTGS transaction is not a payment confirmation. NIC/SBI shall not be responsible for any kind of delay in payment status confirmation.

All bids tender documents are to be submitted online only and in the designated cover(s)/envelope(s) on the e-procurement website. Tenders/bids shall be accepted only through online mode on the e-procurement website and no manual submission of the same shall be entertained. Late tenders will not be accepted.

The scanned copy of required documents specified below, Tender documents duly filled, e- payment form duly filled shall be submitted online and subsequently in a separate cover physically superscribing the name of work and tender number to Devaswom Commissioner, Cochin Devaswom Board, Thrissur through Registered post/speed post before the time of opening of Tender. Hard copies shall be submitted only after submission of online documents.

The required documents to be submitted online are

- 1) Registration certificate of supplier with KMSCL or equivalent Government agencies
- 2) ISO certification of medical equipment
- 3) CE certificates
- 4) Last 3 years IT return
- 5) Brochure of equipment supplied
- 6) List of previously supplied institutions
- 7) Warranty and AMC details

The bids shall be opened online in the office of Devaswom Commissioner, Cochin Devaswom Board or the Competent Tender opening

authority in the presence of the Bidders/their representatives who wish to attend the same. Cochin Devaswom Board will not be responsible for any error like missing of schedule data while down loading by the Bidder. If the document submission date/opening date happens to be a holiday or not working due to any valid reasons, the tender opening process/submission of document will be done on the next working day. On awarding contract, the supplier should submit a security deposit amounting to 5% of the total cost of the items and execute an agreement with Cochin Devaswom Board in prescribed format in Rs 200 stamp paper. The supply of all equipments/materials to be effected within 10 days from the date of work order.

All conditions prevailing in Cochin Devaswom Board/KMSCL/ Kerala Government regarding tenders are applicable to this tender also. Further details, if required, can be had from the office Cochin Devaswom Board during office hours.

Any discrepancy/omission or error in the Tender documents is to be brought to the notice of the undersigned, 5 days before the stipulated time of Tender submission. The authority to accept any Tender/reject all Tenders without assigning any reason is vested in the Cochin Devaswom Board. Any litigation, which may arise related to the Tender, will be under the jurisdiction of District court, Thrissur
